LATICRETE reserves the right to update instructions, technical data sheets and other information at any time without notice.

LATICRETE will pay for replacement of its own products and any finishing products directly damaged from being in contact with them, but LATICRETE will not pay more, calculated on a square metre basis, for the replacement than the original purchase price of the portion being replaced. LATICRETE will not pay for replacement of any portion of the installation that is not proven to be defective.

In the event that the sole and exclusive remedy described above fails of its essential purpose the liability of LATICRETE is limited to the monetary value, on a square-meter basis, of the original purchase price of only the portion of materials being agreed as in need of replacement. LATICRETE IS NOT LIABLE FOR ANY INCIDENTAL DAMAGES OR CONSEQUENTIAL DAMAGES OR LOSSES ATTRIBUTABLE TO DELAYS INCURRED BY THE PURCHASER OR ANY OTHER PARTY. 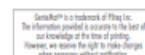
